To help out the RCA with membership this year the Board is excited to be working with two new membership coordinators, Katy Hall and Nell Rumbaugh, to get even more residents engaged with the RCA. Delicious Lunches Delivered to Local Schools

If you have come to our Annual RCF Spaghetti Dinner in June, you've probably gone for a second helping of our tasty Italian meal that was provided by Vignola Gourmet. Giovanni Vignola and his wife Ashley run this local catering business, situated in our nearby Randolph Hills Shopping Center. Many of the Italian recipes were handed down through three generations of Giovanni's immigrant parents and grandparents. The older generation had started out with a pasta shop in the early 1980s, which grew into a popular family restaurant in Rockville. When the new Rockville Town Center was being built up in 2005, the family restaurant had to close; but they continued their catering business. A bit more than a year ago, Vignola Gourmet opened their takeout shop right here in Randolph Hills Shopping Center. It's become a hotspot for the lunch-sandwich crowd and for busy families who want to have home-cooking quality and taste with the convenience of a take-out run.

What makes Vignola Gourmet extra special is the fact that they are now providing school lunches to a dozen schools here in Montgomery County and DC. This started out in 2008, when Giovanni began to worry about the food that his son didn't want to eat in school. They felt that school kids deserved food that was good, homemade and nutritious, and they looked into catering school lunches. Sadly, the budget for public-school lunches hovers around \$2.10 per meal. Not a workable budget for the quality ingredients and care they were aiming for.

However, when they supplied faculty lunches at a private school, the school administrators and parents saw the possibilities. That's how their first contract started out with one private school, to bring home-cooking taste and quality meals to their students. Not only school lunches were a success. Business lunches, corporate catering, galas, charity dinners, family functions and holiday parties increased the Vignola's clientele steadily. With the start of this new school year, the Vignola's now supply a dozen parochial and private schools with their custom-made menus.

I asked Ashley, whose background is in event planning and catering, how they know what their students like, and how varied their food choices are. I was surprised to learn that each school has their own preferences. The all-boys schools are ravenous for lots of carbs, meat with every serving. The most popular selection at some all-girls schools is the salad bar. The Vignola's like to work with their school

clients on the varied culinary offerings: Mexican food day, Asian day, pasta day, and taco day – all of it fresh and seasonal.

Ashley's husband, Giovanni, grew up in an oldfashioned Italian family right here in Maryland, where food played a leading role. He went back to Italy to train at a culinary school in Florence. Many of the recipes come directly from his maternal grandmother, who spoke barely a word of English, even after living in the new country for decades. Her south-of-Salerno Italian recipes stand in contrast to his father's distinct northern Italian cuisine, hailing from Vicenza; and both culinary worlds are represented in their shop. My favorites are the Porchetta sandwich and the Arancini rice balls. Then there's the ready-made lasagna or eggplant parmigiana which you can buy hot, or frozen until you pop them in your oven at home. Of course, for me, nothing beats the pillowy mozzarella balls, made fresh daily, together with some of my own homegrown tomatoes and basil from our Rocking Horse Community Garden.

Vignola's newest take-out offering is their customized New Pasta Bowl, where you pick your starch (rice, pasta, noodles), pick your meat, and pick your add-ons. You can chose from five different homemade pastas, including gluten-free spaghetti, chose from a number of different sauces, and top it off with your choice of toppings. I can't wait.

June General Meeting Minutes

RCA General Meeting Minutes -- June 4th, 2014 By Diane LaGrega Bertocchi

Call to order: 7:50PM

2. Old Business

A. Rocking Horse Center: The meeting for what will happen with the Rocking Horse Center is postponed until June 18, 2014. Brian and Mark will be representing the RCA at the meeting.

B. District 18 Candidate Forum: The candidates' forum was held on May 1, 2014 at the last RCA meeting. It was a great way to meet to the candidates for the primary election on June 24.

C. Road Improvements:

a. Boiling Brook Pkwy and Rocking Horse Rd: There are stripes on Boiling Brook Parkway and Rocking Horse Rd intersection. Plastic posts will be inserted in the intersection to create calming measures to improve traffic congestion in the area.

b. "Hot Right" at Schuylkill Rd and Boiling Brook Pkwy: Strips are also located at the intersection Schuylkill Rd and Boiling Brook Pkwy. Plastic posts will be posted to encourage drivers to stop at the stop sign before turning right. Currently, it is legal to turn right without stopping, but residents are concerned about pedestrians crossing the street into the Randolph Hills Shopping Center.

3. New Business:

A. White Flint Update: Friends of White Flint presentation by Lindsay Hoffman:

Montgomery County is concerned about the demographics of the area and wanted to attract younger people who prefer to use other methods of transportation rather than a car to move around the area. Montgomery County selected White Flint Metro Station because there is already a metro station, buses and wasted space being used for parking lots that could be used for residential and commercial buildings, green space, stores, restaurants, hotels and other modern amenities. There will still be parking, but in the form of parking garages not open parking lots. Currently, residents use their cars for everything, even to run small errands in the area. Rockville Pike is not friendly to walk along because there is no buffer between the road and the sidewalk. The new development would encourage residents to drive less by offering other modes of transportation like rapid transit, bike lanes, and better sidewalks for walking. As the population density in the White Flint area increases, these new developments should help ease the traffic congestion.

a. Pike & Rose: Mid-Pike Plaza will give way to Pike & Rose. Pike & Rose is a 24-acre mixed-use development and the first major project to break ground in the White Flint District of North Bethesda, Maryland. The project will create a street grid of apartments and office spaces with restaurants and shops at street level to produce the feel

of city living. The development will be pedestrian friendly and located across Old Georgetown Road and Rockville Pike from the White Flint Metro Station. The area will have 16 properties, green space, residential, commercial, a new movie theater, restaurants, bars, and theater. Most of the projects will be phased in gradually.

b. Metro Pike Center: There will be a new mixed-use complex that will replace the Metro Pike Center shopping center and Staples at the intersection of Rockville Pike and Nicholson Lane. The west side will have three residential buildings and the east side will have a commercial building and a residential building. Four of the five buildings will have ground-floor shops and restaurants to create sidewalk activity. There will be a buffer with green space and trees between the sidewalk and the road to encourage walking, rapid transit, and a bike lane. A traffic lane may have to be removed to allow for this new development.

c. North Bethesda Market 2: North Bethesda Market II, the property bounded by Rockville Pike, Nicholson Lane, Woodglen Drive and Executive Boulevard unfortunately was a victim of the economy. However, JBG is now ready to break ground. JBG is reviewing amendments to previously approved plans and proposing a mixed-use development. This area is proposed to have the tallest building in Montgomery County. Every developer is including a lot of green space in the development plans.

d. Traffic Mitigation: Currently people in the area always need to use the car. As the malls come down and the parking areas are redeveloped, more streets will be added to ease traffic congestion so one does not always need to get onto Rockville Pike to drive around the area. If we have even 0.1% fewer cars on the roads, there is a sense that the road flows better. Since the area cannot widen the traffic lanes, rapid transit provides a cost effective and reliable form of transportation. Rapid transit buses are a less expensive opinion compared to building a new rail system or new road and are reliable with dedicated lanes and more stops compared to metro to get around the county. The Rapid Transit Bus line will go from the Friendship Heights Metro to Clarksburg, MD. There will also be rapid transit line for Randolph Rd that runs from White Flint Metro Station to US29/Columbia Rd/ Colesville Pike. The RCA will be requesting a stop to serve our neighborhood.

e. Kennedy Shriver Aquatics Center: The parking lot in the area of the Kennedy Shriver Aquatics Center will go but there will be a new Aquatics Center, a White Flint Community Recreation Center, and green space for a park, a new parking garage, and a mixed use residential/retail development.

Church and School are zoned for residential single family homes. They want to rezone for high destiny townhomes; 15 units per acre. There will be a meeting with the board of appeals on September 22nd to decide on the rezoning of the area.

Questions from the audience: What will the rezoning look like? What are the rezoning options? Currently the RCA does not know what the rezoning will look like. The different types of rezoning for townhomes are 6, 10, or 12 units per acre. There is also the fear that they will open the road (Putnam Rd) by Montrose School. Residents are concerned about the traffic. Is the property included in White Flint 2? Loehmann's Plaza is included in White Flint 2. but the RCA is not sure about the Church and the School. It seems like the county wants density. Could we win a fight on decreasing the density where the Montrose Church and School are located? The county wants density near metro stations, but not everywhere. What is the density of other townhouse developments in the area? There are only two other townhome developments in the area and the density is not 15 townhomes per acre. What is the possible timeline? After it goes to the board of appeals, they decide pretty quickly to allow for the rezoning or not. The actual building of the townhomes will be many years out.

Committee Reports:



Safety – There was a car theft and the guy was caught. There was a sexual assault but the person was caught, and the assailant was known to the victim. There's also a new registered sex offender in the neighborhood. http://www.dpscs.state.md.us/sorSearch/search.do?searchType=detail &anchor=true&id=3730956)

Reminder: It is illegal to harass or threaten a registered sex offender. However, it's not illegal to keep an eye out for him and report him if he appears to be doing anything illegal.

Lindsey Hoffman – will continue coordinating the ads for the Echo, if no one else wants will do it [the job has since been taken on by Alison Alexander]. It is \$250 a year and 10% of all ad revenue above \$4000.

RCA Board and Residents Talk Issues and Solutions with Rocking Horse Center Staff

On June 18, 2014, just after school let out for the summer, two RCA Board members, myself and Mark Nensel, and two RCA residents James Lawson and Alice Stevens, met with staff of the Rocking Horse Center (Center) to follow up on a meeting request from the previous March regarding general issues facing residents who live around Rocking Horse Center. This was an opportunity to introduce the Center staff to the RCA and for the RCA to learn a little more about the largest workplace in RCA-land.

The Center, located across the corner from Macon and Galena, used to be the neighborhood's elementary school until it closed. As we learned back in June it is now home to six different Montgomery County Public Schools (MCPS) offices including the English as a Second Language (ESOL) Program; School Counseling, Residency, and International Admissions Office; Early

Childhood Program and Services (Pre-kindergarten and Head Start); Division of Title 1 Programs; Child Find Office (special needs programs); Bilingual Assessment Team; and the Montgomery County Department of Health and Human Services School Health Services Center (immunizations). Because there are so many different offices located at the Center, the staff that oversees the Center is not entirely sure how many employees actually work there. During our meeting, Ms. Woodson, the Center Director and Director of the ESOL and Bilingual Programs Office, noted that they were working on getting a better estimate of the total number of employees.


Many of the programs housed at the Center serve students and their families. Thus, depending on the activities taking place, there can be quite a lot of traffic and, subsequently, street parking spills all the way down Macon, Galena, and Hunters. The volume of activity on the street also creates a situation where sometimes trash is left in the gutter or the County right-of-way. In order to help with this issue the Center staff requested, and received three outside trash bins. Although I think the trash bins

could have been better placed along Macon Road, it is a step in the right direction in taking some ownership over issues that arise indirectly from Center activity. It was noted that if the three trash bins are abused by placing inappropriate trash in them, then the Center may have to remove them.

In order to alleviate traffic congestion in the street, it was suggested that the RCA get in touch with the Montgomery County Department of Transportation to discuss bump-out options so that the corner of Galena and Macon would not be blind during the day. It was also discussed whether the MCPS bus stop at the corner of Galena and Macon could be moved so that traffic could better proceed down the portion of Macon Rd between Galena and Rocking Horse Road that does not prohibit parking on one side. We said we would look into MCDOT's continuing the parking prohibition along one side of Macon to the section of Macon between Galena and Rocking Horse Rd.

The RCA intends to keep engaged with the Center regarding several issues including maintenance, perhaps some beautification projects, and parking. Overall it was a good first

Montrose Christian Redevelopment Update

In my June Echo article I asked for residents who had opinions about the re-zoning request for the property to reach out to me and share them. Several of you did reach out and shared concerns which I have attempted to summarize below.

Residents on the 5000 block of Macon are already abutting low density multiple family (3,000 sq ft per dwelling) and multiple family medium density (2,000 sq ft per dwelling) zones from the apartments on Parklawn. Thus any new high density development on the north side of Macon may make the area feel walled in. Residents raised issues regarding traffic and the existing bottleneck at Parklawn and Randolph. There could be an increase of cut through traffic on Rocking Horse Road due to increasing congestion at Parklawn and Randolph. Concerns about student capacity at Viers Mill Elementary School were also raised. Concerns may also express that any re-zoning should be done only after the White Flint 2 planning process which may be taken up by the Planning Board as soon as this winter (http://www.montgomeryplanning.org/community/whiteflint2/). In addition to larger issues were questions about how the units would be built, if it would be a low-income housing development, and if the developer would request re-opening Macon Rd to Putnam

On July 28, RCA board members and a local resident met with the potential developer of the Montrose Christian church property in the church offices to share the concerns above and learn more about the development plans. Palisades Development, represented by Mr. Steve Baldwin, began the meeting by apologizing for the manner in which the letter from Dr. Fentress of Montrose Christian was sent to residents back in first week in May. Mr. Baldwin explained that they wanted to get the zoning request by May 1st in order to be considered under the existing zoning requirements. Montgomery County passed the new zoning code on March 5, 2014 and they become effective on October 30, 2014. As a result the application process was a little rushed. Mr. Baldwin further explained that it was not a matter of something new in the new zoning regulations, but the fact that they were new and perhaps unfamiliar to County planners that led them to file the rezoning request under the old code.

In addition to the concerns listed previously, we expressed the neighborhood's concerns regarding the unknown nature of the future development, the lack of communication following the May 1st letter, and the lack of trust in Montrose Christian by neighbors abutting the property that stem primarily from recent lack of grounds maintenance. These factors have led to a generally poor reception of the rezoning request by RCA residents.

Mr. Baldwin continued to explain that although the requested zone (RT-15) could allow for up to 130 units on the site, he anticipates it will be more in the 100-105 range. He anticipates that the units will face forward onto Randolph Road which will have two entrances as well as an entrance

on Putnam. There are no plans to request re-opening Putnam Road to Macon Road. Mr. Baldwin explained that they are in the very early design phase of the project and that they are willing to work with the RCA on the development plans prior to the rezoning hearing. In fact Mr. Baldwin has agreed to discuss where they are in the development process and answer neighborhood questions at the October 2, RCA General Meeting. The re-zoning hearing before the Office of Zoning and Administrative Hearings has been re-scheduled for January 23, 2015. I greatly encourage residents of RCA-land to come to the October 2 meeting to hear from the developer directly and ask any questions that you may have.

Venture Crew 27 News

Venture Crew 27 is one of the largest and most active Crews in the National Capital Area and it meets right here in Montrose Park (the RCA-Land neighborhood directly across Randolph Road from the Safeway). Venturing is the Senior Division of the Boy Scouts of America and participation is open to young women and young men who are 14 years of age or who have finished the eighth grade. Venturers age out at the end of the calendar year following their twenty-first birthday. Meetings occur every other Sunday evening from 7:30 to 9 PM.

Crew 27 attends Goshen Scout Camps for two weeks every summer at Camp Bowman. The Crew goes during the last week of June and the week that includes the 4th of July. Nearly every member has completed National Youth Leadership Training (NYLT) and we'll send a large contingent of new Venturers to NYLT this summer. Last summer the Crew sent 19 Venturers and 6 leaders to the National Jamboree near Mount Hope, WV and they camped with scouts from 30 different nations including Japan, England, Ireland, Taiwan, Korea, Germany, Chile, Kenya, South Africa, Mexico, Guatemala, Brazil, Scotland, France and Sweden for ten days. During the summer of 2015, we'll be sending a contingent of Venturers to Japan for the 23rd World Scout Jamboree.

Every summer we take a weeklong trip to some fascinating part of the country. Last summer we visited southwestern Ohio where we studied Native American culture and visited the National Museum of the United States Air Force in Dayton. Our side trips included Fort Ancient (Google it - it is fascinating) and the outdoor drama Tecumseh in Chillicothe, OH where we saw a version of the history of the Shawnee during the American invasion of their homelands. This summer we headed for Michigan and the home of the legendary Paul Bunyan stories where we camped on the Lake Huron beach, canoed the Au Sable River (while watching a large bald eagle population), visited Mackinac Island, and spent a day at Cedar Point Amusement Park and another day at The Henry Ford Museum. Our Venturers are regular attendants at Philmont Scout Ranch, Florida Sea Base and the Charles Sommers (Northern Tier) Canoe Base in Ely, Minnesota.

Crew 27 sets its sights high and emphasizes leadership, ethics, outdoor education, camping, backpacking, water and life skills. We are joined with Sea Scout Ship 27 who can be found plying the waters of the Chesapeake in a 31 foot sailing vessel. Attention Dog Walkers: Pee is dangerous to plants! by Karen Helfert

In most cases, dog walkers in RCA-Land pick up dog poop (bless them), but the poop, if left where deposited, is mostly an obnoxious bother for home owners to deal with. Much more damaging to lawns and gardens bordering our sidewalks is dog pee. It may not seem like so obvious a problem, but it is in fact more insidious and damages appear later. Dog peeing on plants can damage or kill the plants, especially with repeated incidences.

Dog pee contains concentrations of nitrogen and salts...all waste products of a dog's metabolism. It's true nitrogen can be a fertilizer, but NOT in the high concentration found in dog pee. Dog urine also contains uric acid salts. Salts suck moisture from leaves and roots alike and kill beneficial soil microorganisms. In addition, the highly acidic or alkaline urine may alter the pH of the soil. Thus, the pee not only damages the plant itself, but over time it changes the chemical composition of the soil the poor plants are trying to grow in.

So dog walkers, be a good neighbor, and please try to keep your dogs (on a leash, of course) from peeing on homeowners' lawns and plants.

meeting.

The next steps, as concluded and agreed on by all parties at the June 18 meeting, included: 1) the Center will finish installing outside trash bins, 2) the Center will follow-up with the RCA regarding the number of staff working at the Center, 3) the Center will follow-up with the RCA regarding a traffic/parking study, 4) RCA will work with the Center staff on potential grounds beautification projects, 5) RCA will investigate traffic/parking measures with MCDOT, specifically curb extensions on the corner of Galena and Macon and a parking prohibition along one side of Macon between Galena and Rocking Horse, and 6) both RCA and the Center will work to keep an open dialogue.

Venture Crew 1083 By Ben Pitkin

From July 13th to July 19th, the members of Venture Crew 1083's High Adventure component spent a week on the High Knoll Trail at the Blue Ridge Mountains Council's Scout reservation in Virginia. This was the first time a 1083 Philmont Crew-in-training has visited High Knoll, in rugged high-altitude terrain in the Jefferson National Forest, southwest of Roanoke. It was a spectacular week and the learning experiences only sharpened the skills of an already well-prepared group as they continue training for their July 2015 trip to the Philmont Scout Reservation in New Mexico.

In the Scouting program, High Adventure refers to long-term outings, typically in wilderness settings. These outings require intensive preparation, with many weekends spent on "shakedown" hikes and campouts, practicing strict leave-no-trace camping principles; building long-range and high-altitude hiking stamina; discovering which items are indispensable, and which ones are just extra weight, on extended backpacking trips; learning to cook, clean, and purify drinking water on the trail; preventing injuries and, if needed, providing first aid in remote settings; managing any kind of weather within a very wide range of extremes; and protecting bears and hikers alike by suspending food, garbage, and other "smellables" at night from ropes strung between trees at least 20 feet off the ground.

High Adventure is a big-ticket endeavor, and along with unparalleled outdoor experiences, it teaches its participants how to work in creative ways to help defray some of the costs. In that way, they learn the importance of paying at least part of their own way—and how to go about it successfully. One such way is by sponsoring the RCA Spring and Autumn Bazaars, held in May and October in the (former) Loehmann's Plaza parking lot.

The coming Autumn Bazaar will be on Saturday morning, October 11. In addition to sponsoring the event, the Crew provides the food and beverage sales for hungry and thirsty bazaar-goers and vendors. Because the proceeds support the Crew's High Adventure component, every bit you do to help—and enjoying a burger and a soda helps—is most appreciated. Be sure to check the RCA Yahoo group for any late-breaking additional details about the Bazaar.

Venturing is open to coed youth aged 14 through 20. The Crew will meet every Monday night during the school year, from 6:30–7:30 pm at Viers Mill ES. Why not join us?
