Code Enforcement Highlights Meeting

What a Meeting! On Thursday, March 2, the RCA had one of its largest turnouts in years (over 50 attendees) at the General Membership Meeting, which featured two guests from county code enforcement offices.

While the issue that prompted this meeting was the existence of commercial trucks in residential areas, many other enforcement issues were covered including sheds, building codes, drainage, and pets.

I had traveled about our neighborhood taking pictures a few days before the meeting, and showed them for the inspector's opinions and resident's reactions. I also included my own home as an example (it's not perfect!).

The main issue, commercial trucks, is resolved as follows. It *is* permitted to have commercial trucks in a residential area under the following conditions:

- 1) There can be no more than one (1) commercial truck on a property
- 2) It must be less than 19 feet in length
- 3) It must be less than 8 feet in height (including racks, if any)
- 4) It must be under 10,000 GVW (gross vehicle weight)
- 5) It must be parked off-street.

Commercial trucks are not permitted to park on the street.

Another issue was pets. Thanks to Joan Kraft, a visitor from Viers Mill, a web site was found with the latest regulations regarding animals in residential areas:

This site has links to two areas: Summary of Montgomery County animal control laws and complete text of the Montgomery County animal control code. New laws were passed just last year (August 6, 1999), and cover areas that were discussed at the meeting, such as excessive odors from animals.

We thank County inspection officers Steve Morris and Randy Wyrick for their time, excellent commentary, and humor.

Education Committee Looks at Our Schools

Several RCAers have responded to the call offered in the March ECHO article "Children Too Scared to Go to School?" Improving our schools is a concern of many residents. Coincidentally, the North Bethesda Congress (RCA is a member) received a postcard from Montgomery County Public Schools that "MCPS now is studying possible proposals for boundary changes, one or more of which could affect your neighborhood."

I found two proposals on this site, one for the Richard Montgomery cluster, and one for the Town of Kensington, which involves the Einstein and Walter Johnson clusters.

Changing the school boundaries is not the only way to improve our situation, but it is one way. Other tracts we can take involve improving the Wheaton cluster, perhaps starting by inviting principals, school board members, and/or the superintendent to a RCA meeting.

Special County Council Election for Our District

Betty Ann Krahnke to Step Down

There will be a special election on Tuesday, April 18, 2000, just for our council district (#1), to elect a new council representative. Our present local county council representative, Betty Ann Krahnke, will retire that day because of health reasons (Lou Gehrig's disease).

Ms. Krahnke is a Montgomery County institution, and we will miss her. She was always a "sensible-growth" advocate, both when she was on the Planning Board (MNCPPC) and the Council. She also felt that development should adhere to master plans.

When the RCA got the district 1 boundary changed in 1991 to include Montrose and Franklin Parks (so that the entire RCA would be in the same district), Ms. Krahnke went door-to-door in those neighborhoods to introduce herself. She used to hold community "sessions" (I attended one at the Davis Library), where

attendees could ask her questions and get immediate answers. They were basically short, one-on-one conversations with constituents. Representation doesn't get better than that!

We hope it will stay as good, however. There are two fine candidates running, either of which would represent the RCAwell, both of whom have long-standing Montgomery County credentials. One is Patricia Baptiste, another former Planning Board member, and the other is Howard Denis, a former Maryland State Senator. Like Ms. Krahnke, both Baptiste and Denis are sensible-growth advocates. When on the Planning Board, Baptiste was the only member to vote against the re-zoning of Loehmann's Plaza. Mr. Denis was instrumental in a number of reforms at the State level, including the open-meetings law. Locally, he supported the formation of five council districts in Montgomery and helped Ms. Krahnke in all her races.

The only issue where I see significant difference in the two candidates is their philosophy on transportation. Ms. Baptiste puts more emphasis on TDM (traffic demand management), existing road and intersection improvements, and public transit. Mr. Denis would add more roads to that list of solutions.



Large item, Bulk Item Trash Pickup

Are you wondering about how to get rid of couches, chairs, televisions, rugs, clothes washers, refrigerators, etc??? Call county trash collection at 240-777-6410 between 8:30 am and 5 pm, Monday through Friday, to arrange a special pick-up.

You have to listen to the "options" menu (dial 1 for schedule, 2 for hours, etc), and get a "real person." There is no option for large-item pick up. The "live person" will take your name, address, and a description of the items to be picked up. You have to call before 9:30 am on Friday to get the stuff picked up on Monday. But if you miss one Monday, the next one is only seven days away. So please call. Place items to be picked up on the grassy area between the sidewalk and the street.

The county will pick up computers, scrap metal, you name it.

The trash does not have to be your property, so if you see a pile of trash next to the street anywhere in our neighborhood, it's fair game for pickup. I called a couple weeks ago and got a chair and sofa picked up. Let's keep our neighborhood as good looking as it can be!

New Zoning Regulations

Snow? Forgettaboutit!

Montgomery Council Member Phillip Andrews introduced legislation that will REQUIRE homeowners to shovel snow & ice from sidewalks (including the driveway part) in front of their houses. County regulations already require commercial property owners, including apartment buildings, to remove snow & ice from sidewalks and walkways "as quickly as possible" after a storm. There were a number of pedestrians hurt after the "blizzard of '00" because they were forced to walk in the street. Homeowners who fail to remove the snow and ice quickly, possibly within 48 hours, could be fined! The RCA notes that Northern cities have similar regulations, and most objectionable details (e.g., elderly unable to shovel and unable to pay shovellers) have been worked out.



the articles below, derives from the MCCF. The RCA usually agrees with the MCCF policy positions, but not always. The RCA has been a long-standing member of the MCCF for many years.

MCCF Interviews Chief Moose

The MCCF had Charles A. Moose, the new County Police Chief, as a guest speaker. The Chief worked 24 years in Portland OR, the last few as Chief of Police. Chief Moose has a Master of Science and a PhD from Oregon State University. Chief Moose was direct in his answers, a pleasant surprise and very different from the usual political guest speakers. In one interesting exchange, the Chief pointed out how much faster the County population has increased, much faster than the police force has.

MCCF: Council Public Hearings are Unfair

The MCCF analyzed how the County Council scheduled public hearings before them. The RCA (usually Richard Zierdt) has testified at many of these hearings on your behalf. The MCCF made some interesting observations we had not noticed before.

People wishing to comment on impending Council legislation sign up ahead of time. The MCCF notes that

every speaker, whether they represent just themselves or 1,350 RCAhomeowners, gets 3 minutes! Furthermore, the Council attempts to "balance out" the number of pro and con speakers, even though there might be 30 times more speakers on one side of the issue than the other. Think about that: this methodology does not provide fair representation for County citizens.

So, if there were pro-communist legislation pending, the Council's going to "balance" the number of "pro" versus "con" speakers? A fairer method would be to use the total number of persons requesting a chance to speak, pro & con, as a statistical universe, then allotting speakers, pro & con, to represent this universe. Naturally, we also suggest civic associations representing many people should be given precedence over the lone individual speaker.

Gardening Tips


Robins, wild onions, and wild garlic are a sure sign of Spring! Spray pre-emergent in late March to stop some 40-plus weeds, including clover, chickweed and ragweed. Spade and trash ornamental cabbage. Rake debris from lawn. Tune-up the lawn mower, change the oil, and sharpen the mower blade. Home Depot has a sharpener drill attachment that can be used without removing the mower

blade. Buy an inexpensive electric lawn "pH test." A lawn pH of 6.5 is ideal. Pulverized dolomitic limestone will raise the pH in the shortest amount

of time.
