Code Enforcement and Clarksburg Building Violations

At RCA's last meeting, May 4, we hosted four Department of Permitting Services (DPS) personnel who are expert in their field of Montgomery County zoning. I was impressed with their knowledge, and that all four came and addressed the RCA on building issues. They knew what was "right" and what was "wrong."

I also came to appreciate the difference between knowledge of the rules and the related task of enforcement of the rules. DPS does not enforce rules. Housing Code Enforcement does, and County police to a certain extent.

Where Clarksburg comes in is the level of concern shown over building violations there, where the developer is not fined for poorly built homes, but because some of the homes are too high (some just 6" over the limit) or too close to the property line (insufficient setback). Yet when home additions are built in RCA-land, where RCA's Environment Committee chair Matt Tifford has to call multiple times to get an inspector to show up reluctantly, and where substantive violations were discovered at one RCA home, it seems that the County enforcement mechanisms don't care.

I am not saying the Clarksburg building zoning violations should be dismissed. I am saying that the County Council set the stage for this non-compliance when it failed, and continues to fail, to keep enforcement and inspection staffing at levels commensurate with County growth. I also note that the zoning violations, which are not life threatening, are being scrutinized more harshly than safety violations. Something is wrong here.

I am a believer in the "broken glass" syndrome, which says that a single, broken window in a neighborhood, while in and by itself might be considered benign if it stopped right there, can be a catalyst for a whole set of more serious trouble: more broken windows, then more trash, then break-ins, then you-name-it. If less serious violations are ignored, more major violations will inevitably result.

If the County Council is going to fine the builders of Clarksburg, and it probably will, it really should take a fresh look at itself and its support of code enforcement in general. ■

Minutes of the May 4, 2006 General Membership Meeting

RCA 2nd Vice President George Gadbois calls the meeting to order at about 8:10 PM. The room is filled with residents and visitors, including one candidate for State delegate from District 18, which is our district.

Program: Home remodeling permitting. Our guests are four representatives from the County's Department of Permitting Services (DPS): Susan Scala-Demby, Gail Lucas, Sandra Kaiser, and Sandra Batterden. They bring copies of several documents on zoning, development standards, Homeowners Electrical Exam (for the true Do-it-yourselfer). Most of those present picked up copies.

A general discussion ensued about buildings in residential areas. A permit is needed for all sheds (!), even those thought of as "temporary." Even "Pods" – temporary storage units used when moving – require a permit.

The affect of remodeling on property taxes is unknown by DPS, who referred such questions to the Maryland State Assessment Office.

Some random facts: There is a 30% lot coverage — meaning covered by any building with a roof. It is possible to pave over your entire lot, but as long as that pavement is not covered by more than 30% of roofed buildings, fine. Storm water runoff is not a problem. If you flood your neighbor's home in the process, that's OK (I'm not making this up). It is not a code violation — it simply becomes your neighbor's problem.

Building or replacing a fence requires a permit. The maximum building height is now 30 feet, down from 35.

Call 240-777-6259 to report permitting violations.

After the program, there was general discussion about the upcoming RCA Yard Sale, and education in the Down-County Consortium, where most public school students of RCA attend. No motions were made. ■

Voting in September? Consider This

Primary Election Day is Tuesday, September 12, 2006, which occurs before the September *Echo* will be distributed.

The RCA has not recommended any specific candidates, although it could. But certain suggested guidelines might help in deciding who's worthy of your vote. One check I like is the amount of money that corporations, notably developers, give to a candidate's campaign.

I have donated to many different candidates over the years, perhaps as high as \$200 in some cases. Generally, however, the most I contribute is my vote. But how about \$4,000? And if that isn't enough, how about \$4,000 more from your spouse?

Why is it that some entities will give that kind of jingle? What's in it for them? Could it be favorable treatment from the candidate should that candidate be elected? And could that favorable treatment be at odds with what you consider fair?

There is an organization that tracks campaign contributions, Neighbors for Better Montgomery, at www.neigh borspac.org. Click on "Campaign Funds" to see how much money has been reported to each candidate. You might be surprised.

I won't tell you who to vote for in the primary election, but I ask you to see where a candidate's funding is coming from and consider the implications. Thanks for reading.

Tree Maintenance Badly Needed in RCA

The number of missing and dead trees is alarming, compared to the way the neighborhood looked 20 years ago.

I canvassed several streets of RCA-land two years ago for missing trees, and again on April 22. I came up with a list of 120 addresses that needed trees, shown below. I did not inspect all streets, so even this list is lacking. My standard is one tree per residence, and two if the property is a corner lot. Occasionally, a lot is so configured in an elongated fashion as to require three trees in my opinion. These trees are on the "County Strip" between the sidewalk and the street. This is County-owned land, but residents are expected to mow its grass, etc. The trees are not optional – they cannot be declined by the homeowner. On the other hand, they are supposed to be maintained by the County: planted, trimmed, and replaced as necessary.

In April, the County Council passed an emergency appropriation of \$1M for tree maintenance as part of budget decisions. I hope this is enough. The County has neglected tree maintenance for so long, there used to be an 18-month backlog. Now it seems to be six. I'm not convinced how that is measured, however. It seems the only time the County (Department of Public Works and Transportation) works on trees is when someone calls. DPWT does not go out on general inspections on its own. In other words, see no trees, hear no trees, plant no trees. My sense is that the overall condition of trees in this County is worse that \$1M will fix.

President Bush Visits Our Own Parkland Middle School

Some of you may have caught this on the news, but President Bush dropped into Parkland Middle School on Tuesday, April 18 for a scheduled visit. He was there to promote technology, an academic theme for Parkland,



as a part of the federally-funded MCPS Middle School Magnet Consortium grant. He gave a short speech talking about his plan to increase innovation in the economy, mentioning fair competition with other nations to avoid isolation, by striving to be the most innovative. To do this, programs emphasizing math and science, such as the Aerospace Technology theme at Parkland, will bolster the nation's poor grades in these areas and hopefully spur more innovation.

Parkland offers courses like "Applied Aerospace Investigations" and "Introduction to Robotic Systems" to students, some as soon as sixth grade, in order to expose children early to technology and subject matter that will keep them interested in education for some years to come. Bush toured the sixth-grade astronomy, algebra and robotics classrooms during his visit. The current sixth graders are the only ones fully involved in the Aerospace Program, though the seventh and eighth graders benefit from "spillover" effect and a severely less populated environment than in previous years. On hand for the visit was Dr. Weast, community superintendent Frank Stetson, BOE president Charles Haughey and others. Bush said schools like Parkland provide a solution to a growing problem. Many students were gathered at points to both shake the President's hand and exchange a few words. The president arrived and departed on the Presidential helicopter.

The MSMC is made up of Parkland, Argyle, and the newly-opened A. Mario Loiederman (old Belt), and was kicked off this past fall. Those RCA families not part of the WJ Cluster (Tilden MS) are entitled to select their child's middle school from the three MSMC schools. The MSMC is open for application to a lottery for all MCPS students. Students selected that are outside the Parkland/Argyle/ Loiederman attendance area receive bus service if in WJ, Rockville or BCC clusters; all others must provide their own transportation. Students inside the attendance area obviously get bus service.

As many of you know, Parkland Middle School has been relocated for two years to the holding facility at the former Tilden Middle School location. (Tilden Middle school is cur-

rently housed in the former Charles Woodward High School building on Old Georgetown Rd.) The reason is to begin the muchawaited and delayed MCPS Parkland renovation project. This move was effective after the last day of school in June of 2005. Since then, the Parkland home location has been undergoing major demolition. Please see photo at left for status picture as of April 2006. In this author's opinion as a professional in a related field, progress could be much further along. However, it is common knowledge that school buildings are typically slated for "just-intime" completion so they do not

remain empty and unused for measurable periods of time. Technically the project started in September of 2004 for design, and then construction was to have started in February of this year for a completion date of August 1, 2007. By the looks of the photo, the schedule seems to be slipping with no actual "construction" started. The structure remaining is the gym along with some key iron members to be reused in the new design by Moseley Architects.




News from Pack 1081


Troop 1083 News

Dear Mrs. Brown



Every summer we get visitors to our home. We also visit friends in different parts of the country. Are gifts expected?

After staying in anyone's home a thank you note must always be sent within a week of your return. A gift along with the note is very appropriate. The gift chosen, however, should be something for the entire family you have visited or something for the house. While you are a guest, it is helpful to look around and get ideas to what they might need or appreciate.

What is that old rule about wearing white shoes and does it still apply today?

The "old" rule is: Never wear white shoes before Memorial Day or after Labor Day. The exception to the rule is tennis (athletic) shoes. Does it still apply today? Yes. It is a traditional society rule – especially in the Washington area – yet most people consider it passé. But I say, go for it! Have some character, even if it's for your own self-satisfaction.

Would you please help me explain to my teenage daughter why manners are important, especially table manners?

Teenagers have a difficult time understanding the fact that they will be judged more on their manners, (which include not only table manners, but all typical practices, such as choice of clothes, speech, and forms of behavior) than their character. Manners are the customs, if you will, of any given society. Those who violate these customs are almost certain to arouse extreme distaste in those who do obey them. This is as true of subculture manners, such as those in a teenager's world. In their world, they may be outraged to see anyone mishandling a guitar or video game, for example.

To answer your question, the point to make is that your child will *someday* want the good will of people who do know table manners: a boyfriend/fiancé and his parents, new friends at a sorority in college, co-workers or clients. And *right now*, she needs the approval of someone very important in her life – you!

Whenever our family gets together my aunt makes some very rude comments to my brother. No one says anything to her about it, not wanting to cause friction. What do you suggest?

Good manners recognize situations in which it is necessary to be respectful, polite and also able to convey to another person that you will not tolerate bad behavior. Honor requires you not to let these insults pass. Your reply should be: "I am very fond of my brother and I don't appreciate your negative comments about him." After letting that sink in for a second or two, add, "I have never heard him speak unkindly of you."

Children Who Are Not Your Own

The world is full of children whose parents have not bothered to teach them any manners, which you may perhaps have noticed. That is why all good meaning adults have a great obligation toward the children who come under their sphere of influence. Let them get lucky and be a stepparent, adult friend, grandparent, or other relative or teacher who will take over that task.

It is a more difficult task for such people than it is for the original parents, who have more time and influence and a presumption of authority. Anyone stepping in with less clear authority must first obtain the child's desire to please him or her. Affection, tact, and a myriad of qualities that the child will admire and try to be like are needed for this, in tremendous quantities. But children, who observe a pleasantly ordered way of life, different from that to which they have become accustomed, and if they are led into this by someone of whose love they are convinced, will respond.

A child who is learning proper behavior from you will have it at their command in the future, whether or not this behavior is reinforced in their own home. Often children of conflicting influence will choose the better when they are more mature and independent.

Chicken Marbella

Yield: 16 pieces, 10 or more portions

The distinctive colors and flavors of the prunes, olives and capers make this a spectacular party dish. The overnight marination is essential to the moistness of the finished product. The chicken keeps and even improves over several days of refrigeration and it travels well and makes excellent picnic fare. It's good hot or at room temperature. The recipe can successfully be divided to make a smaller amount if you wish.

In a large bowl combine:

4 chickens, 2 1/2 pounds each, quartered

1 head of garlic, peeled and finely pureed

1/4 cup dried oregano

coarse salt and freshly ground black pepper to taste

1/2 cup red wine vinegar

1/2 cup olive oil

1 cup pitted prunes

1/2 cup pitted Spanish green olives

1/2 cup capers with a bit of juice

6 bay leaves

Cover and let marinate, refrigerated overnight.

Preheat oven to 350° F.

Arrange chicken in a single layer in one or two large, shallow baking pans and spoon marinade over it evenly. Sprinkle chicken pieces with:

1 cup brown sugar

Pour around the chicken

1 cup white wine

Bake for 50 minutes to 1 hour, basting frequently with pan juice. Chicken is done when thigh pieces, pricked with a fork at their thickest, yield clear yellow (rather than pink) juice.

With a slotted spoon transfer chicken, prunes, olives and capers to a serving platter. Moisten with a few spoonfuls of pan juices and sprinkle generously with

1/4 cup finely chopped parsley or cilantro.

Pass remaining pan juices in a sauceboat.

To serve Chicken Marbella cold, cool to room temperature in cooking juices before transferring to a serving platter. If chicken has been covered and refrigerated, allow it to return to room temperature before serving. Spoon some of the reserved juice over chicken.
