President's Message

By the time you receive your copy of the *Echo* this month, we will either be nearing or just past Halloween. I hope all of the young people in the neighborhood had a great celebration and did everything chocolate in moderation. Please remember to take extra care while driving, as you leave for work in the morning and when you return in the afternoon, young people are going to school, coming home from school, playing in the neighborhood and enjoying the outdoors in this most colorful of seasons.

We are watching our public servants and working diligently in our quest to turn around the plan being presented by the staff of Park and Planning to demolish our recreation center at Randolph Hills Local Park. At the time I am writing this message, no inspection has been completed on the building to determine the extent of damage done by the elements and lack of maintenance by the Parks Department. I've had interviews with the Montgomery Sentinel, The Gazette, and the Washington Post on our reaction to the Park and Planning Department Plan for our Rec Center. I've said my piece and didn't pull any punches. Several other members of your RCA board have also been interviewed. So far, the news media has accurately reported our views and thoughts on the matter. I'm really glad I'm not the public official who presented this truly misguided idea in the first place.

As a citizen, I am dumbfounded that our elected officials would consider trusting the same Montgomery County Park and Planning

Department, who is incapable of maintaining their current recreation centers as "Stewards of the Public's Trust", with Montgomery County's share of the \$80 million dollars to build and then maintain a new headquarters building in Silver Spring called Silver Place. Building a new headquarters for the Park and Planning Department will not serve the citizens of Montgomery County in any way that I can see. The money would be better spent supporting the citizens in their parks with new recreation centers instead.

Another aspect of the Park and Planning staff's argument is that these facilities do not pay for themselves. I counter that if they were originally intended to be self supporting, they should be made part of the Montgomery County Revenue Authority's complement of facilities which are self supporting and frankly, in many cases, much better maintained. Recreation Centers are not now nor were they ever intended to be self supporting. Nor are Public Libraries, Nature Centers, Police Stations or Fire Departments intended to be self supporting.

I would encourage our elected officials, those members of the County Council and the County Executive that I mentioned in my message last month, to take the Park and Planning leadership out to the wood-shed and have a frank discussion about the importance of their purpose to serve the public and not engage in building edifices. If they want to build something, how about building a new Recreation Center in Randolph Hills Local Park. With the \$80 million saved by not building a monument to themselves, they could build a lot of citizen use facilities. Take a moment and let your county legislators know your feelings on this matter. They really do respond to our thoughts and ideas on this matter. Councilmember Roger Berliner is scheduled to attend the December 6th RCA General Meeting at Veirs Mill Rec Center starting at 8:00PM. Please come by and let Roger know your thoughts in person. Also at that meeting, Mark Wallis of the Park and Planning Department is scheduled to present the Park and Planning proposal to the affected citizens. They are taking notes so be sure to be heard. I will schedule as much time as necessary to give as many RCAers as desire to speak or get questions answered. The meeting may take longer than usual but we will be heard. Please come and provide your input.

Until then, these are the names and addresses you need to write, call or email. Roger Berliner is our councilman, and at large council members representing us are Marc Elrich, Nancy Floreen, George Leventhal and Duchy Trachtenberg. Ike Leggett and the other council members are getting input and comments from their districts too. Lets keep the pressure up!

Minutes of the RCA Executive Meeting

September 6, 2007

This was RCA's first meeting in the Veirs Mill Recreation Center. Our Randolph Hills Local Park Recreation Center is closed – Park and Planning wants to demolish it!

Our RCA Recreation Center was the focus of this Exec meeting. The Execs were disappointed that a newspaper reporter from the Montgomery Sentinel was a no-show, but later the Montgomery Sentinel and the Montgomery Gazette interviewed RCA President Mike Saunders. The reporters were interested in RCA's fight for our Recreation Center. Look for future newspaper stories on this subject. Look for the details of our fight to save the RCA Recreation Center from being demolished, in this month's and last month's *Echo*.

The Execs are fighting to save our Rec Center with all their might: meeting with County Councilmember Roger Berliner, speaking with Councilmember Marilyn Praisner, letters mailed to County Council officials, contacting other civic groups, and anyone else who will join us to save our Rec Center.

The Execs believe Park and Planning have already decided to demolish our Rec Center and are now instigating a PR campaign to smooth over civic opposition. After much discussion, the Execs decided to honor Park and Planning's request, and allow them to address an RCA Exec meeting. Whether Parks is allowed to address a RCA General meeting remained undecided.

RCA President Mike Saunders, following the meeting agenda, turned to the *Echo* newsletter, how we publish Hotline calls and crime reports. Previously, the Execs had much email traffic on whether the RCA should print neighborhood crime, reported on our Hotline. This discussion came about because of a break-in reported on the Hotline. The Execs decided that a suspect's race/ethnicity would not be reported. Like any newspaper, the *Echo* is sometimes edited for content (e.g., use of inflammatory language).

Normally, the RCA does not print neighborhood crime. The RCA previously reported: car break-ins for spare change; cars side-swiped; and once when shots were fired in our neighborhood. The Execs will monitor RCA-land crime to determine how much there is, and whether it is worth reporting.

2nd Vice-President Dan Hoffman suggested the RCA consider hiring an off-duty Montgomery County police officer to patrol RCA-land. A subsequent review revealed that the Police Union, Fraternal Order of Police, handles these service requests. The rate is \$35 per hour, with cash or check going directly to the police officer. The RCA does not have

the extra funds, but would love to hire an officer for the RCA Community Yard Sale, or to patrol the neighborhood at night, or to write tickets. The Town of Chevy Chase, which is smaller than the RCA but is a municipality, has a full-time officer.

RCA-land dead trees are being cut down from county right-of-ways, before they fall down. This county maintenance is good, but the Execs want to ensure new trees are planted as replacements.

Mike quickly covered the next agenda items. Our update on the Franklin Park sign would have to wait. RCAer Saul Kopyto is the project manager for the new sign, but sent his regrets he could not attend the meeting. The Execs decided our RCA picnic will be held at our Randolph Hills Rec Center, even if it is closed. Mike reported that RCA now supports Brownies as well as the Girl Scout Troop. The RCA continues to sponsor our Boy Scout Troop and support its feeder Cub Scout Pack. The RCA has some SAMs Club memberships that were never picked up nor paid for by RCAers. These will be returned to SAMs for refunds.

RCAer Karen Helfert volunteered to review RCA's Constitution and By-laws. Her review is complete, and she asked the Execs to consider revisions. Any changes must and will be approved by the RCA general membership.

Minutes of the RCA General Meeting

October 4, 2007

President Mike Saunders opened the first General Meeting to be held in the Veirs Mill Recreation Center (at the Northern end of Beach Drive in Rock Creek Park). Our Randolph Hills Local Park Recreation Center remains closed because Park and Planning wants to demolish it!

The first order of business was our closed Recreation Center. Both a Park and Planning representative (Mark Wallis) and our County Councilman Roger Berliner were expected to guest speak, but their attendance was postponed until the next General Meeting, Thursday, December 6, 2007. Meanwhile, the RCA will rally everyone to fight to save our RCA Recreation Center. Councilman Berliner will hold a public forum at the BCC Regional Services Center in Bethesda, and Mike urged RCAers to attend.

Next, President Mike Saunders introduced RCAer Ed Shaw, a representative of 5LINX, an on-line marketing company offering digital home phone service, video phones, wireless phones, high speed internet, and satellite TV. The RCA discussed how we could benefit from "click-throughs" – on-line users who would use an RCA website link to buy goods and services, thus generating an RCA commission payment. The RCA will explore web-site revenue-generating plans further, and any expenditures would be pre-approved by the RCA general membership (approximately \$95 annually).

RCAer Shaul Kopyto is leading the effort to get Franklin Park a new sign. The present small sign, at Randolph Road and Hunter's Lane, is over 40 years old and termite-ridden. Shaul worked hard, collecting Franklin Park donations doorto-door, getting sign estimates and plans, and is now ready to start construction! Saul was given a round of applause for his efforts. The RCA hopes to have a ribbon-cutting ceremony later this year, and Franklin Park contributors will be honorably mentioned in the *Echo*.

Passed by unanimous voice-vote: that the Execs would draft a Conflict of Interest Statement for RCA Officers. Also Treasurer Dell Pillers/Cline will present a treasurer's report at the next meeting.

Second Vice-President Dan Hoffman reported on his efforts to revive RCA's Neighborhood Watch. Dan acquired crime data from the last year that identified car and house break-ins, pin-pointing local problem areas. Dan is hosting a Neighborhood Watch meeting at his house next week with a Montgomery County Service Officer as guest speaker. The purpose of the meeting will be to review crime reports, identify trouble spots, develop evaluation lists, and organize Watch Patrols. The RCA could hire off-duty County police officers to patrol RCA-land, much like nearby municipalities do. Dan asked volunteers to leave their contact information with him. If you are interested in the Neighborhood Watch,

Return of the Neighborhood Watch

After an increase in the number of burglaries and vehicle break-ins over the last six months, a handful of residents have decided it is time to revitalize the Neighborhood Watch (NW) in the area covered by the RCA. An initial meeting was held in October. The purpose of the newly reformed group will be to:

- Track incidents with an eye towards identifying "hot spots" within RCA
- Coordinate and fund additional police patrols in the neighborhood
- Reduce chronic neighborhood infractions (e.g. speeding on our main roads, cars blocking sidewalks, and illegally parked commercial vehicles)
- Develop a network of neighborhood captains and a chain of communication to alert our neighbors in cases of emergency
- Increase the general awareness of our neighbors to the activities going on in their own neighborhood

Depending on the level of involvement/interest we receive from residents, the scope of the NW could expand to include activities such as an escort/assistance program for our neighbors who are elderly, disabled, or may just feel vulnerable traveling at certain times. The NW may also develop a network of "safe houses" for children who are traveling through the neighborhood and feel as though they are in danger or are being pursued. Foundation May Replace Many Functions of the Association

Most Dues May Become Tax-Deductible

Starting this civic season (2007-08), the role the Randolph Civic Foundation plays in our community will increase and assume some of the responsibilities of the Randolph Civic Association. The intent is to allow the Foundation to perform the educational and charitable functions that the Association used to do. These functions include, for example, presenting guests at general membership meetings and supporting our Boy and Girl Scout troops. The goal is to enable most of the membership dues asked for each year to be completely tax-deductible, not just the amount donated over and above the amount given to the RCA. Also, the cost of producing and distributing the *Echo* might be borne by the Foundation, and ultimately become exempt from Maryland sales taxes.

To assist in this endeavor, I've retained the services of attorney Steven M. Katz of Rockville to help us make this transition (no RCA or RCF money is involved). It is important to keep the operations of the Foundation and Association separate, so this issue of the *Echo* will include a separate listing for the officers of the Foundation, and separate meeting minutes (RCA and RCF). Treasurer reports for the Foundation will resume in the next issue of this newsletter (there has been no activity to report by press time for this issue).

A website for the Foundation has been started, www.RandolphCivicFoundation.org. The website of the Randolph Civic Association remains the same, and will be kept.

So why two organizations, and what's their difference? The Association will continue to represent the interests of the Randolph Community before the County Council and state delegations. As an example, the hottest topic currently in play is the fate of our recreation center building. The Association is working hard to keep our "Town Hall" alive and prevent its demolition by Park and Planning. The role of the Foundation is to educate the community and support our children and adolescents. The Foundation will sponsor programs at its meetings to help us understand, as examples, crime prevention, consumer protection, and transportation – topics that are important to those living in a suburban environment.

The cost of running the Foundation will increase, and the cost of running the Association will decrease. But at least the dues collected for the Foundation will be tax-deductible.

Greetings RCF-land! As the recently elected President of our newly re-formed Randolph Civic Foundation, I would like to share with you some changes to expect to see over time. As the charitable and educational arm of our community civic group and sister organization to the RCA, the RCF will focus its involvement primarily on the areas of our targeted charities as well as a means with which to educate our community. The RCF will accept tax-deductible donations from individuals, corporations, and from the RCA to be used to benefit our various youth Scout groups, fund costs that may be associated with having a guest speaker on an educational topic, such as gardening or local history, and promoting environmental stewardship.

The RCA will remain our business and lobbying arm of the organization, while the RCF, in more distinction than in the past, will oversee the aforementioned philanthropic and educational piece. The distinction being made at this time will better qualify the RCF as the tax-deductible entity it is, and enable the federal 501(c)3 application process to proceed smoothly for our




