Back to the Future Election District for RCA-Land?

As hopefully many residents learned at the October 1st RCA meeting, Maryland Delegate Al Carr is drafting legislation to reunite RCA-land into a single election district. This would bring back together precinct 4-15 (area north of Randolph Road, votes at Rocking Horse Center) and precinct 4-26 (area south of Randolph Road, votes at the Viers Mill Rec Center) into a single precinct and polling place.

The election districts were re-drawn after the 2010 census split RCA-land into two districts on either side of Randolph Road. This has meant that residents of Randolph Farms, where the Rocking Horse Center polling location is located, could no longer vote at that location. This defied all logic for many residents in that area.

Delegate Carr is seeking input from residents regarding this proposal. If you missed Delegate Carr's presentation at the October RCA meeting there is still plenty of time to give feedback. The bill hearing isn't until Monday, November 30, 2015 in Rockville before the Montgomery County Delegation. Final action on the legislation wouldn't be until mid-January 2016. RCA President's Message - October 2015

Dear Neighbors, it is hard to believe that fall is now upon us. October brings with it Community Day, which by the time this is published will already have occurred. I hope everyone had a great time! October also holds a favorite "holiday" for many residents, Halloween. In the eight years I have lived in the neighborhood I have seen trick or treating ebb and flow with the neighborhood age groups. I always try to have my kids visit our immediate neighbors before we head over to Franklin Park (Otis Drive) where there are some residents who like to put on a spooky Halloween display. If you know some good local Halloween destinations send me an email and we'll share them via Facebook and our neighborhood Yahoo email group.

As I've written about previously, the White Flint 2 Sector Plan has kicked off. In fact, I hope we are able to provide some community feedback to the owner of the Randolph Hills Shopping Center over the coming months regarding how our neighborhood envisions future development. There is a separate summary in this issue of the Echo regarding the first outreach meeting about schools in the Walter Johnson Cluster. That feeder system is facing some potential overcrowding issues that residents would like addressed before approving any new development. This is currently not an issue for the Wheaton H.S. feeder schools, of which we are a part. Speaking of Wheaton H.S., the information I have currently indicates that new school construction remains on schedule to have the students move into the new building the first week of January after winter break. It should be a pretty impressive new high school when all the work is complete.

I have mixed feelings to learn that original developer of the Montrose Christian Church property is no longer a part of the project. After amicably parting ways, the Church has identified a new developer. The RCA is actively engaged with the Church to learn more about what the new developer intends to do on the site if granted their re-zoning request. As we go to press the re-zoning hearing for the new townhomes is still set

for December 11 and we have invited them to present their plans to the commujnity on December 3rd.

According to the WSSC website the Rock Creek sewer rehabilitation and repair at the Garrett Park Road bridge should be finishing up by October 21. I know that many residents along the Rock Creek Park boundary experience sewer back-ups fairly regularly. This repair work is supposed to alleviate that problem. Also in Rock Creek Park the County has installed a lot of new signage. I think it will be hard for anyone to get lost in the trail system now. I especially like that it looks like they finally standardized the mile markers along the trail.

As the days get shorter I urge residents to keep an eye out for cyclists and pedestrians who will become harder to see in the mornings and evenings. Happy pumpkin carving to all!

Old Business

Postponement of Montrose Baptist Church June 19, 2015 OZAH meeting until December 11, 2015. Since the meeting has been postponed, we have more time to work on testimony for the zoning.

Boy Scouts of America Meeting Court of Honor and ECHO distribution. Brian Hooker and Diane LaGrega Bertocchi attended the Court of Honor meeting on June 15th 2015 at the Elk Lodge in Rockville, MD for Boy Scout Troop 1083.

New Business

New transparency in communication (Google).

Brian Hooker would like to move away from the current file management and communication system used by the RCA. The RCA has a Google nonprofit business account that offers all of the RCA's needs in one system. The RCA has enough accounts and document storage through Google for each position on the RCA board. This way the board members can view all necessary documents. Brian Hooker makes a motion to move all our RCA business to Google enterprise. Mara Greengrass seconds. Passes 5 to 0.

Review of 2016 budget and current finances.

Mara Greengrass is the treasurer. The accounts are healthy and the RCA plans to put the budget online for community members to view once the everything is moved over to Google documents.

Federal tax update

Due to IRS changes in the way that non-profits file their taxes back in 2007, the RCA needs to pay a new application fee. Once the application has been approved, the treasurer will file the electronic postcard for the IRS for the RCA at the end of the fiscal year beginning in June 2016.

Neighborhood News Bites

Rock Spring and White Flint 2 Master Plan Meeting, Sept. 17, 2015

On September 17, 2015 a public meeting was held at Walter Johnson High School (WJHS) regarding the Rock Spring and White Flint 2 Master Plan, and how it affects school enrollment in the Walter Johnson Cluster. Gwen Wright, Glenn Kreger, and N'kosi Yearwood, and Pam Dunn from Montgomery Planning Department and Bruce Crispell from Montgomery County Public Schools (MCPS) Division of Long-range Planning explained how they plan for schools and listened to comments from the audience.

The new development for Rock Spring and White Flint 2 Master Plan includes multifamily housing, such as condominiums and townhomes. The presentation showed many statics on how multifamily housing will have very little impact on the number of children attending the current schools in the Walter Johnson Cluster. For example, the newly build PerSei apartments at Pike & Rose yielded only four elementary students, zero middle school students, and one high school student.

The presenters emphasized that the enrollment surge is caused by turnover of existing single family homes rather than the new development of multifamily housing. There has been an increase in enrollment in the Walter Johnson Cluster since 2007. Many of the schools are over capacity as of the 2014-2015 school year.

The solutions presented at the meeting to help reduce class size were: Reopen a closed school in the cluster, construct a new school on a future school site, purchase land for a new school, and consider nontraditional options, including those being studied by the Cross-agency work Group on School Design.

According to members in the audience, who were mostly parents of children in the Walter Johnson Cluster, all of those ideas have been presented before and are always voted down due to lack of funding.

Parents were upset with Montgomery Planning for not incorporating the building of new schools into the new development plans for Rock Spring and White Flint 2 Master Plan. Many parents complained that the schools are overcrowded now and the county representatives have not presented any real solutions.

Garrett Park Road Bridge Update

Below is our latest communication from MCDOT. It appears that the project has been pushed back in order to allow time to secure funding from MSHA. Our current understanding is that once funding and designs are complete, the Garrett Park Road Bridge will be replaced and pedestrian path lighting will be installed along the length of Garrett Park Road between Schuylkill Road and the bridge.

"We are in the process of obtaining a cost sharing agreement between the Montgomery County Department of Transportation and the Maryland State Highway Administration (MSHA) to obtain federal funding for the design of this project. Within a couple of months we should get Notice to Proceed for the design of this project from MSHA and at that time a schedule for the design of the project will be determined. Our best guess at this time, is that we should have 30% plans for Mr. Shoemaker in approximately 2 years." 

September 21; 10:27pm: I'm calling in regards to the bump outs on Boiling Brook Parkway. I live on Schuylkill Road, and we were wondering how the bump out at the intersection of Boiling Brook and Schuylkill Road was going to affect how the storm water drains at that intersection.

RCA Response: Thank you for submitting your comment. The MCDOT traffic engineers included cut-outs in the bump-outs for storm water flow. During heavy rain events it is foreseeable that this could result in slightly longer periods for the water to drain off. However, if you witness standing water where water is not draining please call MC311 and let the RCA know as well so we can follow up with them. I don't believe we've had any significant rainfall since the bump-outs were installed.

September 17; not anonymous: I really don't have time to get involved in the meetings and committees of the Association. But as a resident of Randolph Hills, I keep asking why are the bump outs at Boiling Brook and Schuylkill necessary, a stop is now mandatory where it was not for at least the last 40 years. I've never heard of an accident there, or a pedestrian being hit. At any rate, I guess those ugly things are there to stay, so my question is who decides on building these things. I believe the money spent on that would be better used in repairing the streets throughout the neighborhood. They are so bad that even brand spanking new cars rattle. To me the bump outs just seem like a way to put a contractor friend to work. It is going to be a lot of fun for the snow plows this winter.

RCA Response: The RCA has been striving to improve traffic and pedestrian and bike access from the neighborhood to the shopping center for a few years. The current traffic calming measures were recommended by the Montgomery County DOT after we asked them to evaluate the intersections to see what could be done to improve them. Their solution is nothing new in the County. In fact, the same approach was taken on Wexford Road in the Palisades neighborhood in Kensington (off of Beach Drive).

September 13; Not anonymous (RCA notes that there were several messages with this same question): So I'd like to send in my membership form but there is no address.

I thought it was a crime to run stop signs. I've lived in this neighborhood more than 20 years and it's been a problem every day, weekday or weekend.

RCA Response: Thank you for sharing your frustration. As you note this is a long term issue and one for which the RCA has been actively trying to identify solutions.

A Message from MCPD District 2

by Capt. David Falcinelli, Commander 2nd District Dear Residents of the 2nd District:

TRAFFIC: As we move into Fall, the 2nd District officers will be making a big push to keep drivers focused on the road. Traffic congestion is a big problem and while we cannot do much about the volume, we can certainly do something about crash prevention. We are trying to get smarter about where we apply our resources. We have identified the top 12 crash locations in the District. Intersections along Rockville Pike/Wisconsin Ave., Old Georgetown Rd., Connecticut Ave. and River Rd. are all on the list. It is no surprise that distracted driving is one of the biggest offenses contributing to these crashes. I have attached a brochure outlining the

cell phone laws in the state of MD [reprinted in this issue of the Echo on page 8]. To be fair, I am telling you up front that we will be conducting several cell phone enforcement operations in the near future. We already did two along River Rd. and issued over fifty citations/warnings at each in a short amount of time. Preventing crashes is one of the best things we can do for public safety!!

Recently, a highly valued member of our community lost his life in a very tragic cycling crash. The laws are designed for cyclists and cars to share the roads, but there continues to be offenders on both sides that pick and choose the laws they want to obey. I am meeting with the Executive

Director of the Washington Area Bicyclist Association next week to discuss how we can collaborate to make the roads safer for all parties. In the meantime, drivers need to remember to give cyclists three feet of space when passing them. Cyclists need to remember that they are vehicles, and as such, must obey all rules of the road just like a car.

CRIME: We are continuing to move in a positive direction sharing current trend information even more frequently with all other police districts and the investigative units. The goal is to identify the trends sooner and make the apprehensions more quickly to prevent further crime from occurring. (continued on page 15)

While we have certainly slowed since the end of summer, the problem of thefts from autos continues. Just last night, a victim reported that property was stolen from their car. The car was unlocked and parked in their garage. Unfortunately, the garage door was left open overnight allowing easy access to the suspects. Time and time again we see home security system videos of suspects trying car door handles and simply moving on

when they are found to be locked, yet every month anywhere from 50-80% of theft from auto victims report that no force was used to enter their car. 1. Lock your cars! 2. Remove anything of value or anything that appears to be of value. 3. Close your garage doors especially at night and 4. Call the police when you observe suspicious persons in your neighborhood.

Many thanks to the concerned resident that observed a suspicious person yesterday in the Elm St. parking garage walking in and out of the parked cars. The call was made to us, and the suspect who had been stealing items from cars, ran from the police but was apprehended a short distance away. We recently honored a very young man who lives in our district for his role at observing some suspects at a pool parking lot stealing items from cars. He also called us and gave a very detailed description of the suspects and their vehicle. They were also arrested a short distance away.

We are most successful when we work together to keep our communities safe. I was taken aback recently when a caller to the station thanked me for taking her call, thinking that I was too busy to listen to her concerns. It is my job to listen. I may not always have the answer, or sometimes may not give you the answer you want to hear, but I remain committed to hearing you out and doing the best I can to address legitimate concerns that are raised.
