New for 2012: The RCF Block Party Sponsorship Program

The Randolph Civic Foundation is pleased to announce the new RCF Block Party Sponsorship Program. In case you haven't heard the term before, a Block Party is an event where a resident of the community, with the help and agreement of their neighbors, closes off one or more blocks of a neighborhood street to throw a big outdoor party. These events can range from simple affairs, with light refreshments and kids enjoying the freedom of riding their bikes and scooters up and down the quiet street, all the way to extravagant carnivals, with food, drink, live music -- you name it. Due to their current popularity nationwide, ideas for planning Block Parties are easily available online, with a few sample links available on the Foundation website.

Here is the process for putting together a Block Party:

- Approach your neighbors and agree on a date and time
- Plan the food and entertainment and delegate responsibilities
- Submit a completed Sponsorship Request Form (available on our website) to the Randolph Civic Foundation
- Allow up to one week for Board approval
- Upon approval, apply for a permit through the county (link available on our website)
- Request an event announcement in the Echo (optional)
- Put up flyers or deliver door to door
- After the event, submit receipts for food/non-alcohol drinks/entertainment, along with a copy of the county permit
- The Randolph Civic Foundation will reimburse up to \$150

President's Message

Happy New Year RCA-land! Winter in our neighborhood can sometimes feel a bit dreary. Because of all our mature trees and green space, personally I feel we are at our best in spring and fall when everything is either blooming or the leaves are colorful. Although a reasonable layer of snow can also look nice, please do be careful when navigating our neighborhood in icy conditions. With cars parked on both sides of the street the roads can be narrow, and we have an increasing number of children in our neighborhood. Also remember to clear your sidewalks in a reasonable timeframe and help others who may have trouble doing this.

At our February meeting we discussed our priorities for this year. Although this Echo will probably not be delivered to your door until after our February meeting, please know that you can approach the RCA at any time with a concern or request. We are happy to help you and guide you. Sometimes County processes are onerous and confusing. Given that we are an all-volunteer organization, we will ask you to help out as well. At any given time we are working on a dozen different neighborhood issues and appreciate new faces. Check out the March Echo for an update on our work plan for this year.

There are many challenges and opportunities on the horizon for RCA-land in the coming year. Some of these will end up in our work plan, while others are just things to be aware of. Planning for White Flint Two will begin, and this will offer us another opportunity to transform the commercial and industrial property immediately surrounding our community. The Randolph Hills Shopping Center, Loehmann's Plaza, Parklawn Drive, and Randolph Road will be areas of focus during this process. I am confident that in 7-10 years this community will be vastly changed, and for the better. Nuisance property owners and businesses that hurt our community (such as Nationwide Imports and the fortune tellers on Randolph Road) will also likely be gone if we work and plan properly. RCA-Land Welcome Wagon Rides Again

"Hello! Welcome to the neighborhood!" is what you might have heard from the RCA Welcome Wagon if you were new to the neighborhood in the past two years. We are a small group of friendly faces that have eagerly greeted nearly 80 new residents with home baked treats, information about the RCA and its surrounding area, and best of all, welcoming faces. Moving into a new neighborhood can be hectic, lonely, and honestly a lot of hard work, so a few of us got together with the goal of helping ease that transition. Extending a handshake, a smile, and some encouragement to be part of the neighborhood civic association can mean a lot to a new resident. Typically we are met with a look of surprise and great appreciation and leave after a few minutes of pleasantries. Often we depart the doorstep with the home baked goods already devoured, especially when we catch our new neighbors in the midst of a new homeowner's project such as painting, renovating, landscaping, or something similar.

The group gets together every 3-4 months on a weekend afternoon and covers an average of a dozen houses in a two hour timeframe. The list of new neighbors is gathered with help from Denise Szczur, a local real estate agent specializing in RCA-land sales. Traveling from one house to the next is typically done on foot and is a great way to experience the neighborhood. To many of the group's members, the neighborhood has gotten a lot smaller since becoming a part of the Welcome Wagon. Walking gives us a great sense of the layout and the different terrain of RCA land. From Waverly-Schuylkill Park, the new community garden, Rock Creek Trail, to Randolph Hills Park and more, there is much to explore while visiting new residents and there is much information to share with them.

Each new resident is given a one-page leaflet filled with interesting information and tidbits, such as the neighborhood wine club, garden club, and dog club; the variety of transportation choices (Metro, MARC, bus, bike trails); nearby shopping options; the nearest post office; plus tips on how to get involved with the RCA.

The Welcome Wagon is a fun and simple way of staying in touch with our neighborhood and regaining some of the face-to-face conversation that often gets replaced by today's technology. We are hoping our efforts result in a friendlier and more active neighborhood. So if you are a new neighbor or if you have been here for years, welcome to the neighborhood! We hope to see you at the next RCA meeting to continue the conversation.

December General Membership Meeting Minutes

1. Call to order: 8:05 p.m.
2. Guest Presentation: Lerner Enterprises Present Plan for the White Flint Mall Property
 - These are the highlights followed by some Q&A:
 - * White Flint mall property is just over 45 acres or about 10% of the overall sector.
 - * Plan will consist of a grid of streets with new roads
 - * The mall as it is currently known will be torn down. Only several existing structures will remain.
 - * Buildings along the Pike will be as all as 200 feet, but buildings closer to the residential will not exceed 50 feet.
 - * All phases of the Lerner plan consist of about 2400 new housing units and 5.2m sq feet
 - * There will be a central piazza of 2.1 acres and Lerner is donating an additional 2.5 acres for a public park
 - * The plan will be built out in 4 phases
 - When will Nebel Extended connect straight through from south to north? Not until Combined Properties who own White Flint Plaza redevelop.
 - When will this happen? County processes will take about two years but after that it will depend on the market development.
 - Will all of the retail be shut down during construction? Unknown. They will work with existing tenets.
 - What about dust and particulate matter during construction? They will take all precautions.
3. Guest Presentation: Community Gardens Update:
 - Ursula SabiaSukinik, the Community Garden Coordinator of Montgomery County Department of Parks, Horticultural, Forestry, and Environmental Education Division gave an overview of our Rocking Horse Community Garden. The garden, located on Macon Road, next to the Rocking Horse former grade school, was established a year ago, on property leased from the Department of Education. This past growing season proved successful, and many gardeners have renewed their plots. Half of the garden plots are available now for seasonal rental for neighbors and residents county-wide. Applications will be filled on a first-come-first-served basis. The plots are either 200 or 400 sft in size. For more information go to www.MontgomeryParks.org or call the new community garden coordinator at (240) 876-7598.
4. Old Business:
 - a) George Gadbois, of our Education Committee, gave a Wheaton HS modernization update, reporting that the project might be back on track, after the big show of support by community members, parents, teachers and students at the previous month's "Listen &

Learn" meeting with the new superintendent. The Garrett Park school modernization is nearing completion, and the work at Walter Johnson HS is almost done.

b) Matt Tifford reported on Quiet Zone.

We formed a Quiet Zone committee of Randolph Hills residents, reaching out to Garrett Park residents, as well as our county representatives and rail executives. Our objective is to reduce the blasting of the train horns at the crossings, and to examine possible crossing upgrade measures. We are planning to get a stakeholder meeting together in January, and need more active participants.

5. New business:

RCF successfully sponsored an Eagle Scout project, which resulted in the installation of our new signs in five locations. RCF paid for all the signs with your donations. The Scouts did the installation. It was a great job, and we send a big thank you to all the scouts and volunteers involved. A new Eagle Scout project will be installation of park benches for pedestrians in the area. We welcome suggestions for suitable locations for placement of the benches. The Scouts held another council-wide food drive which yielded 77,000 pounds of food collected, an increase of 10,000 pounds. We've been holding food drives for over 20 years. Thank you all for your generosity! The Boy Scouts held their annual Christmas tree sale on Saturdays and Sundays, on the corner of Beach & Knowles.

We held our third year of Neighborhood Caroling on Monday evenings in December, organized by Christiana Drapkin. We welcomed the volunteers, families, friends who joined in the joyful noise.

6. Standards Business and Reports

a) Treasurer's report tabled. We are in good standing. Influx of membership contributions are close to target, around 400 memberships. We want to hit at least 500 household memberships. Please renew and support our neighborhood efforts with your contributions and extra donations.

Minutes approved by unanimous voice vote.

b) Committee Chair Reports:

Environmental Report: You may have noticed when walking through the neighborhood, that many concrete blocks on the sidewalks were heaving up. Instead of digging up and replacing the entire slab, the County is paying to shave off the edges that were jutting up, thereby reducing a tripping hazard. This improvement method came at considerable cost savings.

Public Safety Committee: Good news: The car-jacker at Wheaton Westfield has been apprehended by police. Don't forget our Neighborhood Watch! Please contact our membership volunteer, Mara Greengrass, to join and sign up for various functions with our Neighborhood Watch.

RCA meeting was adjourned at 9:25 p.m.

Open Enrollment for Community Garden Plots starts February 1st

If you'd like to join your neighbors gardening on your own plot at the Rocking Horse Community Garden, enrollment is now open, and applications are taken on a first-come-first-serve basis. There are other community gardens county-wide; the next closest one is Parklawn Garden, behind Franklin Park, accessible from Veirs Mill Road.

Here is what to do: The website www.Parks-CommunityGardens.org is where you will find the application, instructions for applying, and the conditions of use for the Community Garden plots. First, you will need to obtain a ParkPass before you can apply for and rent a garden plot from Montgomery County Parks. ParkPass information is located at the Parks Community Garden site, and you can do that now. They will begin accepting new applications on February 1, 2012.

Please note that ParkPass processes all applications as they are received. Ursula SabiaSukinik is no longer with the Community Gardens program. Her successor, Pat Lynch, started the job in January, and her email is patricia.lynch@montgomeryparks.org. Her phone number is 240-876-7598.

Update on Quiet Zone Initiative

On January 5, 2012, several key stakeholders gathered to reopen the discussion regarding the implementation of a "quiet zone" located at the Garrett Park train station. The "quiet zone" would eliminate the need for trains to sound their horn while approaching the crossing at the pedestrian walkway. We request that CSX sufficiently improve their safety devices to warn pedestrians and others that a train is approaching, without resorting to horn blowing. The meeting included Dan Hoffman, president of the RCA, Ken Hartman, Regional Director of Montgomery County and Jack Mandel, a Garrett Park representative.

Mr. Hartman reviewed where this conversation was left when it was tabled about a year ago. Collectively, the group decided the first step is to get CSX involved to find out exactly what safety modifications are needed for the crossing in order to eliminate the need for the horn. We are in the process of scheduling our discussion with the CSX contact, and once we do, the group will determine how to involve the County and State in this project.

creased access to transit, better linkages to the heart of White Flint, and attractive retail and residential on our borders you will see home values increase.

White Flint Two is also our next opportunity to take another look at Rocking Horse. I cannot imagine the experience my family is having at Viers Mill Elementary School (VMES) to be any better. The principal is amazing and the teachers we've had so far are top notch. They've virtually closed the achievement gap at VMES and are slated to get an addition in a couple of years that will address overcrowding. Plus class sizes are dramatically smaller than at other neighboring elementary schools (18 kids in a class as opposed to 28). So whereas VMES can safely be considered one of the best elementary schools in the County, I know a community elementary school at Rocking Horse would be an asset for the neighborhood. We will again investigate this opportunity during White Flint Two planning.

So this is an exciting time to live in RCA-land and a good time to get involved. You'll see in this issue that we're looking for nominations to serve on the RCA Board, but we also always need volunteers too. Beautification efforts, advocating for the neighborhood, putting together the Echo and organizing events all take time. Whatever your skill, language, or interest, we can definitely find a place for you in our effort to continually improve our neighborhood.

County Laws for Residential Neighborhoods Reminder

In a prominent posting on the Montgomery County website, espousing "Being Good Neighbors: Maintaining the Residential Character of County Neighborhoods", new County Laws regulating certain aspects of residential homes went into effect last year.

Here's a quick refresher course for the Randolph Hills community – a reminder of we should and should not be doing in RCA-Land.

Home-Based Businesses: County residents can operate businesses out of their homes, subject to certain restrictions. Three types of home-based businesses are allowed: no-impact (no county registration is required), registered (requires a permit from the Department of Permitting Services), and medical practitioners (requires county registration). According to the website, "the person who performs the occupation must live in the house. On-site employees are limited to one in a 24-hour period. The number of visits to a no-impact business is limited to five customers/clients a week. A registered business is allowed no more than five customers/clients a day or 20 a week. On-site parking for home occupations is limited to two spaces. Lawn maintenance companies operating as home occupations are allowed only one single-axle trailer or truck at a time.

Parking for Heavy Commercial and Recreational Vehicles: Heavy commercial vehicles and recreational vehicles are prohibited from parking on residential streets, except temporary parking for loading and unloading. Heavy commercial vehicles are defined as follows: a gross vehicle weight of more than 10,000 pounds; a manufacturer's rated capacity of more than one ton; more than 21 feet long (including any object loaded onto the vehicle); or are more

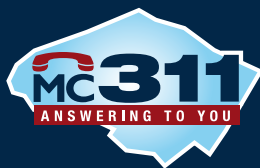
than eight feet high (including racks, but not antennas). These vehicles are prohibited from parking off-street in residential neighborhoods. Recreational vehicles include motor homes and trailers, including those used to transport other leisure equipment. One recreational vehicle per household can be parked off-street on available surfaced area in residential neighborhoods.

Parking Off-Street: Vehicles parked in front yards must be on surfaced areas. There is an off-street parking limit of one light commercial vehicle. Inoperable or unregistered vehicles are not allowed anywhere on the property."

Paving Front Yards: For R-40 and R-60 residential zones (under which much of Randolph Hills' homes fall, i.e. a minimum lot area of 6,000 square feet for each dwelling), the limit is 35% of their front yard or 320 feet, whichever is greater. On major thoroughfares, the limit is 50%, or 320 square feet. Only one vehicle is allowed for every 160 square feet of paved surface.

Enforcement of these laws is primarily instigated by complaint. Home occupations, the paving of front yards and off-street parking issues are regulated by the Department of Permitting Services. Unregistered and inoperable vehicle issues fall under the jurisdiction of the Department of Housing and Community Affairs. On-street parking complaints should be directed to the Police Department. According to the website, "typically, for Permitting Services and Housing & Community Affairs, an inspector investigates the complaint and issues a Notice of Violation if he or she finds just cause. If the violation is not corrected and/or dismissed within 30 days, a citation may be issued accompanied by a \$500 fine. On-street parking violators can be ticketed by the Police."

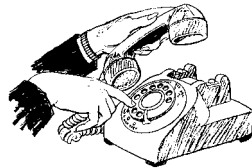

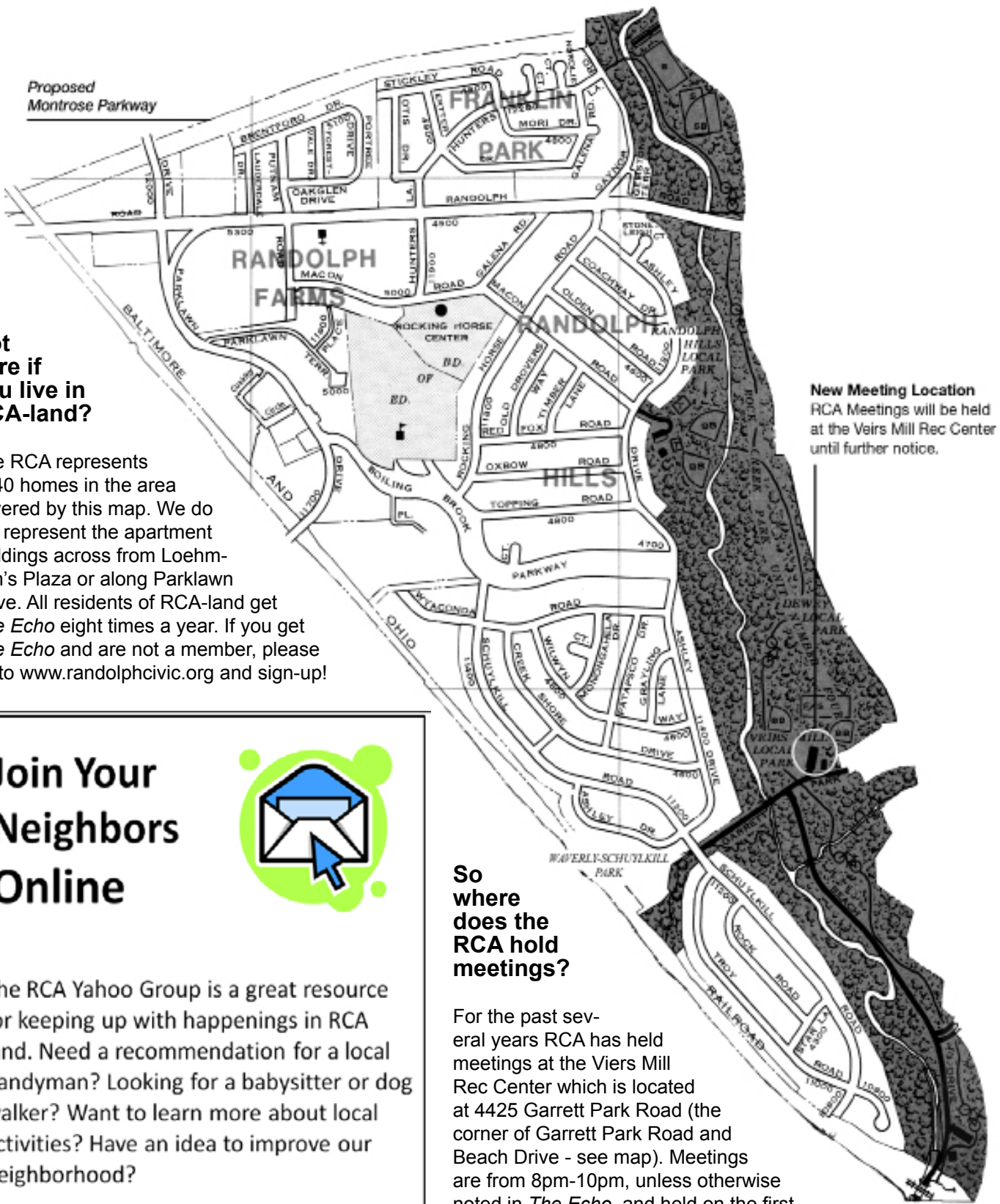
