## Minutes of the RCA General Meeting

May 1, 2003

Vice-President Mike Saunders introduced our guest speakers, representatives of Montgomery County's Housing Opportunities Commission (HOC). HOC was established in 1974 to provide affordable housing for low-income county residents. The HOC has learned it is better to "de-concentrate poverty" – to spread out low-income housing, and not build public housing "projects" that concentrate poverty into one area. HOC owns and manages 6,838 units in the county. In addition, there are other federal housing programs not supervised by HOC. After a 45-minute presentation, the floor was opened to questions.

Mike delicately asked whether HOC house renters are taught the finer points of being a good neighbor, like mowing the lawn and shoveling the sidewalk. HOC renters sign leases that do specify "good-neighbor" requirements. Other polite questions from the floor made it clear that the HOC would not answer an obvious question: is there any subsidized house in RCA-land? The question period ran another ten minutes, and after an hour the HOC reps were given a round of applause.

President Matt Shore, seated in the back during the presentation, now joined Mike at the head table, and turned the meeting to old business. As promised, Secretary Kevin Kline distributed a fresh Montgomery County Police Sex Offenders Registry Listing to any RCA'er who wanted the report ([www.montgomerycountymd.gov/Apps/Police](http://www.montgomerycountymd.gov/Apps/Police)). The bad news is that a convicted "Sexual Child Abuse Offender" recently moved into a house on Dewey Road, just on the other side (east) of Randolph Hills Local Park.

Kevin briefed RCA'ers on four upcoming zoning issues and passed out accompanying text. First, the Washington Suburban Sanitary Commission (WSSC) will finally begin a major construction project through Rock Creek Park, from Veirs Mill Road, across Randolph Road, and stopping near Dewey and Mahan Roads. WSSC is going to replace the 1960's era 42-inch sewer pipe, and the 1950's-era 24-inch pipe that runs beside the Rock Creek stream. An overflow could happen if these pipes are not replaced (whereby raw sewage leaks out through manhole covers).

Winding Creek Park, the section of Rock Creek Park just north of Randolph Road, will be closed for two years, and used as a staging area for heavy construction equipment. Trucks and equipment will use RCA-land's Gaynor Road – and Dewey & Mahan Roads – to haul in large sections of pipe. There will be controlled blasting during daylight hours, to cut through solid rock. The hiker/biker trail



will remain open with detours. The project should be complete in 2004.

Second, the county will build a new road from Nicholson to Marinelli named Citadel Avenue. This new road will be located just west of the Strathmore Court subsidized apartment complex. The RCA has no comment yet, but the Garrett Park Estates-White Flint Park Citizens' Association have strongly endorsed this new road, to alleviate traffic.

Third, the Flagship Center (the Giant food store shopping center) plans on building 150 apartments on the small surface parking lot next to (north of) the parking garage. Kevin recommended the RCA oppose this plan, because of the negative traffic impact.

Fourth, the County Council approved a change to the Master (zoning) Plan, to allow for a massive White Flint Metro Station development called "LCOR." There was some discussion on this topic. The LCOR project is in addition to the White Flint Conference Center that is now being built on the opposite side of Rockville Pike, and the White Flint Office Park, now being built on the northeast corner of Rockville Pike and Old Georgetown Road. Kevin said the RCA has opposed the LCOR development, but that the County Council just approved it. An RCA'er suggested the RCA write a letter to the Council expressing our continued dissatisfaction with this project, and the cumulative traffic impact once these projects are finished.

Treasurer Richard Zierdt reported that the RCA received a check for the insurance claim he submitted. The claim was for the RCA neighborhood sign on Boiling Brook that was destroyed in a traffic accident. Richard asked for suggestions on what type of replacement sign RCA'ers would like to see. The two favorites seemed to be brick or the standard redwood with white lettering. RCA'ers are encouraged to call the hotline and voice their vote.

Mike Saunders opened the floor to new business, and an informal discussion on various topics ensued: A representative of the Veirs Mill Village Civic Association, Kevin Jackson, was in attendance and recognized; an RCA'er reported that the "worst intersection in the county" (Boiling Brook and Rocking Horse) is as bad as ever; and RCA'er Frank Shore got the county to install a park bench at Coachway and Ashley, next to our "Randolph Hills" sign. Frank said the county is also going to install a flagstone walkway, and Black-eyed Susan flowers! Frank was given a round of applause for his achievement. Special thanks to the RCA neighbor who faithfully mows the grass and edges the sidewalk around this sign and park bench.

An RCA'er asked that people stop parking their cars on the grassy strip between the curb and the sidewalk. This right-of-way is clearly county land and parking on it is not only illegal, but tacky. STOP IT!

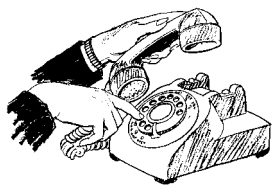
